

Frankly, people of our generation have probably heard lots of talk about crypto (which is short for cryptocurrency), but most of us are not quite sure what it is, let alone whether we should invest in it! So, let's go over a few important facts about crypto.

Crypto is a generic term that refers to digitized money. Without getting too far into the details, it relies on technology to create and store it, which limits its existence. That's part of what gives it value.

The benefits of crypto include the ability to buy and sell things without regard to the value of the U.S. dollar or other international standards, such as the Euro. But, right now, very little purchasing is done with crypto; instead, it is much more popular as an investment.

There are many different cryptocurrencies, with Bitcoin tending to be the most wellknown. There is no government sponsoring crypto, and no single preferred crypto type exists.

On the downside, because crypto is anonymous, it is also preferred by those making sales and purchases of illegal substances, products, and services.

With that in mind, how is crypto viewed as an investment?

First, remember that crypto isn't tied to anything or any country. When you purchase a stock, you own a portion of that business's assets. But there is nothing underpinning crypto, so it could conceivably become completely worthless.

Second, in its short life, crypto has shown lots of volatility. For example, one Bitcoin was worth less than a penny in 2010, worth \$64,800 in April of 2021 and by June of this year, had lost over 65% of its April 2021 value, trading at \$22,601.

Because crypto is not secured by anything, because there is no preferred type, and due to its volatility, financial professionals consider crypto an aggressive investment (sometimes called an alternative investment) with considerable risk.

If you have your heart set on investing in crypto, only a percentage of your assets can tolerate the high potential for losses which should be considered if you decide to invest in it.

#### **How to Support Loved Ones Suffering** from PTSD

It's important to bring awareness to PTSD as many people suffer from this treatable condition and don't seek help due to the stigma surrounding mental health conditions.

Although it may be difficult for families to fully understand what their loved ones are going through, the best thing you can do for those experiencing PTSD is to listen as well as encourage them to seek professional help.

If someone confides in you about their PTSD, it's better to acknowledge and validate their experience rather than say nothing. Let them know what they're feeling is not a sign of weakness, and that help is available. If your family member or friend is scared or hesitant to get help, offer to go with them to get started. Other ways you can provide support is assist them in researching various treatment options and attending treatment with them.

#### What to do When Someone with PTSD **Pushes You Away**

When we see someone we care about struggling, it's natural for us to want to help. However, sometimes that help isn't always welcomed by the other person.

If a loved one is showing signs of avoidance or pushes you away, it's important to give them time. While it's hard to see them experiencing this, it's essential to be patient and be there for them in ways that can help them continue everyday activities. For example, asking if there's anything you can do to help, such as going to the grocery or cooking a meal for them may be the best thing you can do for them in that moment.

It's also important to remember that it will often be their choice on when and where they seek treatment. Forcing this on someone can lead to resentment and distrust. It may even spark an argument that could leave you both hurt in the end. Gently encouraging them to continue

going to therapy once they have started care is important. Acknowledge or celebrate the achievements they make.

Don't pressure them to talk about their experience or what they discussed in their therapy sessions. It's their choice regarding if, when, or what they will share with you. Let them know you are there for them if they want to talk and even if they don't.

## RIPEA Appoints Dr. Robert N. Jackman to Board of Directors



During their June 1, 2022 meeting, the RIPEA Board of Directors voted unanimously to appoint Dr. Robert N. Jackman to a 4-year term on the RIPEA Board.

Dr. Jackman, a Purdue University School of Veterinary Medicine graduate, served in the Indiana State Senate from 1996 to 2008.

Viewed as a strong advocate of District 42, which includes Decatur, Fayette, Rush and Shelby counties, as well as portions of Franklin County, as an elected official, he focused on reducing America's, and by association Indiana's, dependence on foreign oil and sponsored bills promoting railways and mass transit.

Jackman also lobbied on behalf of Hoosier landowners, and fiercely protected their property rights. In 2008, he chose not to run for re-election, instead turning his focus and time toward family and health.

In addition to his legislative work, Dr. Jackman owns the Jackman Animal Clinic in Milroy, Indiana and received the Distinguisher Alumni Award from Purdue School of Veterinary Science and Medicine in 2002.

The RIPEA Board of Directors is pleased to welcome Dr. Jackman to the Board. His legislative experience brings tremendous value as well as strengthens RIPEA's collective voice.
