### **Notice**

In their December 2017 meeting, the Board of Directors voted to require spouses of RIPEA members who participate in a sponsored insurance plan to join RIPEA as an "Associate Member". Dues will be \$10 per year. This policy became effective January 1, 2018 and affects all enrollments moving forward. ## Your Guide to Contacting the Indiana Public Retirement System

When you need to contact the Indiana Public Retirement Systems (INPRS), it's easy to get to a helpful and knowledgeable representative. But before you make the call, please be prepared to enter your Social Security number. This helps verify your identity to keep your account secure.

Depending on the purpose of your call, your PIN might be required in order to make certain changes to your account such as your address and direct deposit information. When you call, you'll have the opportunity to respond to the 'interactive voice response' system. This means that when you say, "I need to log in to my account" the system routes you to the representative best suited to help you. Once your call is answered by a representative, be prepared to confirm your date of birth and address. This additional step helps verify your account. If you have to spend some time on hold, please be patient!

You can reach INPRS at (844) GO-INPRS or (844) 464-6777, Monday through Friday, between 8 a.m. and 8 p.m. ET. If you need to call us after hours, you can email questions@inprs.in.gov. Additionally, answers to many common questions can be found on our website – www.inprs.in.gov.

### **Your Legislative Corner**

The only bill that passed the 2018 Legislature which could affect retired members of RIPEA is SB 373. You may recall SB 373 established supplemental allowance reserve accounts for various state-supported public funds including PERF. The legislature will still have to pass a bill approving the increase (recent years that has been in the form of a 13th check). No other bill affecting RIPEA and its membership became law in 2018.

PERF retirees with an effective retirement date of December 1, 2017 or prior will receive a "13th check" with their September 15, 2018 PERF check or deposit. The additional amount will be, with years of service:

Years of Service	Amount
5—10 (disabled only)	\$150
10—20	\$275
20—30	\$375
30+	\$450

This payment is a result of legislation that RIPEA was instrumental in getting passed during the 2017 Legislature.

- Amounts Over \$1000
- Property Taxes
- Funeral Expenses
- New Roof, New Furnace, Septic Tank Installment, Etc.
- Car Payments, Repairs, or Purchase of a New Car
- Vacations
- College Loans or Tuition
- Mortgage or Home Equity Loans
- Cell Phone Bills
- Cable Bills
- Veterinary Bills
- Legal Fees
